Motion was made and seconded by Commissioners Ruzek and Waller to approve the bid from Harty Mechanical for the water heater replacement at Chauncey in the amount of \$56, 215. ## **6.) Executive Director Reports**

a. Approve Hormel Foundation Grant request

Executive Director Medgaarden proposed to the Board the two programs that he would like to present to the City in consideration for the Hormel Foundation Grants. The first is the WoodChip Loan program which would be for the removal of hazardous or nuisance trees. The second is the Local Housing Trust Fund which would be used to support housing development, preservation, rehabilitation, or financial assistance. Motion was made and seconded by Commissioners Ruzek and Waller to approve the Hormel Foundation Grant requests as proposed by Executive Director Medgaarden. All present voted in favor thereof, none in opposition thereto. The motion was declared passed and carried.
